General Information:

- Entries must be received by closing date, late entries may be accepted with \$10 late fee. Email entries will be accepted, PayPal payment is accepted.
- Current negative coggins required for all horses on grounds, copies are kept on file.
- **ALL RIDERS MUST WEAR ASTM/SEI CERTIFIED PROTECTIVE HELMETS WITH STRAP WHEN MOUNTED, NO EXCEPTIONS!**
- Riders and spectators should be respectful of other competitors. ***No spectators in warm up area!***
- All dogs must be on a leash, all children must be supervised and kept away from horses.
- All USEF rules apply except: leg wraps permitted, coat & braids are not required.
- Awards: Six ribbons for each class; high score award for Training Level & above. Series awards at end of series if entries warrant. Classes will be divided into junior and senior if entries warrant.
- Concessions will be available.
- Management reserves the right to split, combine or cancel classes and add or substitute judges
- Management reserves the right to postpone and reschedule due to inclement weather. Winter shows will generally **NOT be cancelled due to cold**, unless footing is frozen.
