- Entries & payment must be received by closing date, late entries may be accepted with \$15 late fee. No refunds after closing date. Go to Whinstonefarm.com for Pay Pal payment link, add \$5 for PayPal payment.
- Current negative coggins required for all horses on grounds, copies are kept on file.
- **ALL RIDERS MUST WEAR ASTM/SEI CERTIFIED PROTECTIVE HELMETS WITH STRAP WHEN MOUNTED!!**
- All dogs must be on a leash. Children must be supervised & kept away from horses. **No spectators in warm up area!**
- All USEF rules apply except: leg wraps permitted, coat & braids are not required.
- **Awards:** Six ribbons for each class; High score award for Training Level & above if entries warrant. Classes may be combined into TOC. Management reserves the right to add or substitute judges. Concessions will be available if entries warrant.
- Management reserves the right to postpone and reschedule due to inclement weather.
- Winter shows **will NOT be cancelled due to cold**, unless footing is frozen. There will be **no refunds** for those who choose to ride because it is cold!
- Ride times will be emailed and posted on website by 9 pm on Friday before the show
